

Facility moves represent the relocation of certified processes and systems from one address to another, not to be confused with the addition of new facilities or sites to an existing certificate. According to the current version of the Code of Practices (COP) for R2v3-certified organizations, facility moves require an audit of the new address before a revised certificate can be issued.







This is especially important for audit scheduling or changes within 21 days of the intended audit date. Auditors will not accept audit dates or agree on new plans without your scheduler being involved. This helps prevent unnecessary fees, billing issues, F-27 delays, etc.
- Company Contact Changes: It is required that companies notify a PJR representative of any changes to your company contacts for both audit scheduling and accounting purposes. Ensuring that our records are accurate helps us maintain effective communication and streamline our processes, minimizing any potential disruptions to our services.

If there have been any recent changes to your company contacts, or if you anticipate any upcoming changes, please inform your designated PJR representative as soon as possible


